Bob Wheeler, 81 Leroy St -

- Q. How did issue of dissolution come up?
- A. Potsdam Village Board was proactive and addressed concerns
- Q. Assuming a "Yes" vote, what is the Town's responsibility?
- A. Although it's only a village vote, the Town must accept the results and work towards a realistic transition plan
- Q. Regarding the 2 colleges does the Town have any liability?
- A. The Town already has a liability; would assume more
- Q. Will there be tax districts?
- A. former village will pay debt as a tax district; can create districts, except for Police District, which needs special legislation

Helen Brauer, 86 Market St.

- Q. What is the obligation of the Town?
- A. The Town takes its role seriously; it will act on the formulated plan; the Town government will look differently

Charlie Zettek, CGR Consultant Comments:

In the case of dissolution, the town must provide everything but police protection; It can choose different levels of service than the village currently provides (funded by current village taxes). No guarantees

We choose to live in a village, rather than in the Town Outside the Village (TOV) because we prefer the higher level of services and the services provided by a village government; it is then fair to expect to pay for those services.

- Q. What about non-profits?

- A. There will be a final dissolution Plan from the DSC and then a transition plan
