







PRINCETON TOWNSHIP ENGINEERING DEPARTMENT ORGANIZATIONAL CHART




Department of Public Works – Chain of Command




Regional Planning Office Organizational Chart











TABLE OF ORGANIZATION CORNER HOUSE 2012 (Total 12.34 FTE)





Princeton Township Police Department March 2012 Flowchart









HOW TO REDUCE REDUNDANT POSTIONS

- Attrition –allow employees to stay until they leave or retire
- Layoff with severance i.e. 2 weeks for every year of service
- State-authorized early retirement program (ERI) plan
